## 12<sup>TH</sup> Step Service

This service is the heart of the AA program—carrying the message to other alcoholics and giving a boost to our own recovery. As Twelfth Step volunteers, we make ourselves available to talk to alcoholics who are either new to AA or having some sort of crisis in their lives. We may just spend time talking to them on the phone, or we may meet face-to-face. If we are going to meet with them we try to team up with another AA member. Sometimes we decide to take the caller to a meeting. We find there are a variety of situations that call for creative responses. But we always share our experience, strength and hope.

Santa Cruz County Intergroup, through its Central Office and the Diverter Committee, is expanding and improving the Twelfth Step service available to suffering alcoholics. To do that, we ask our volunteers to be available whenever a drinker makes his or her first contact with AA. On most occasions the newcomer can be best served by one or two caring twelfth step volunteers.

We want to have a Twelfth Step volunteer to connect with each newcomer who calls for help. In order to achieve this we must continually update and maintain a list of Twelfth Step volunteers. If you would like to be of service please call Central Office at 475-5782 or stop by and fill out the 12<sup>th</sup> Step Service form. *There is a 3 year sobriety requirement for all Twelfth Step volunteers.*

## Step Ten:

*“Continued to take personal inventory and when we were wrong promptly admitted it.”*

When we retire at night, we constructively review our day. . . After making our review we ask God’s forgiveness and inquire what corrective measures should be taken. . .

On awakening let us think about the twenty-four hours ahead. We consider our plans for the day. Before we begin, we ask God to direct our thinking, especially asking that it be divorced from self-pity, dishonest or self-seeking motives. Under these conditions we can employ our mental faculties with assurance, for after all God gave us brains to use. Our thought-life will be placed on a much higher plane when our thinking is cleared of wrong motives.

### Public Information/Cooperating with The Professional Community (PI/CPC)

Volunteers needed to inform students, probation officers, doctors and others about what A.A. is and what A.A. is not. Servicing literature racks, making sure drug court has a current list of open meetings, or attending health fairs at a school or college. The Committee meetings are on the 3rd Thursday of the month at Central Office at 7:00 PM. Eric is the new Chair and can be contacted through central office.

### Bridging the Gap (BTG) — Bridging the Gap to Lasting Sobriety

Do you remember stepping out of a hospital, treatment center or correctional facility and asking yourself, "Now what?" Sobriety was new. Many of us were full of hope for the future and fearful of what it would take to stay sober. Sometimes we found AA on our own, other times AA reached out to us. Those of us who made it to the rooms of Alcoholics Anonymous found a community of people who were living the solution and eager to share their experience, strength and hope for lasting sobriety. Bridging the Gap (BTG) is a world-wide service offered by AA that supports that very important first step for alcoholics who have just been released from hospitals, treatment centers or correctional facilities. We help newcomers make the transition to AA communities in their home towns. The way it works is newcomers fill out a request for assistance at a treatment facility to get to that first meeting then BTG finds a volunteer that shares the same sex, age, and zip code. Upon release, the volunteer calls the newcomer to find out what kind of help is needed to get them to that first meeting. Frequently, sponsorship blossoms from this encounter.

BTG in Santa Cruz County is making presentations at the Camp Recovery Center, Santa Cruz Residential Recovery and Rountree Detention Center (aka "The Farm"). We receive an average of twenty five requests for assistance every month. Some of those newcomers are local and need local volunteers to reach out to them. We're looking for male and female volunteers from the Watsonville and the San Lorenzo Valley areas, but please don't shy away because you don't live there! Volunteers may be contacted often or infrequently depending on the volume and demographics of the newcomers and volunteers. Interested? Contact Jon B. ### Hospitals and Institutions (H&I)

H & I has lots of service positions available. Ben Lomond Fire Camp is looking for males or females with two years of sobriety to be a Coordinator or secretary on Wednesdays at 7:00 PM. Si Se Puede is in need of male or female secretaries with six months of sobriety, Spanish not required, to secretary on Saturdays or Sundays at 7:00 PM.

If anyone is interested in service work at any of the jails in Santa Cruz County, they are all in need of help. You must attend an orientation, which is held the last Wednesday of each month, at 6:00 PM, at the Main Jail Facility, 259 Water Street, Santa Cruz, CA, 95060. Blaine Street Women's Jail is looking for females with two years of sobriety, with no parole or probation. Water Street Jail Men's Facility is looking for males with three years of sobriety, five years since your last felony, with no parole or probation. To serve at the Water Street Jail Women's Facility you must be female with at least three years of sobriety and no parole or probation. The Watsonville Farm is looking for males with three years of sobriety and no probation or parole to be a Coordinator or Secretary.
