

## **SANTA CRUZ COUNTY INTERGROUP COUNCIL: NOVEMBER 2023**

### **OPENING CUSTOMS: The meeting was opened at 7:33 pm**

The Serenity Prayer was led by Christopher, 12 Steps read by Christine, 12 Traditions by Ed O, and the Safety Card by Kerri.

The 7<sup>th</sup> Tradition was observed, with a pay-pal link included in the zoom chat function. Birthdays were announced- over fifty sober years in all!

Approval of previous month's minutes, with correction to motion for a vote of no confidence, FROM "exempting voting members added to the group august 31 (or later) from participating in a vote on this motion", TO "exempting voting members added to the group after august 31 (or later) from any restructuring of the group resulting from approval of this motion".

## **OLD BUSINESS:**

Tabled motion:

“A vote of no confidence of the Santa Cruz County intergroup steering committee, binding to restructure the steering committee of Santa Cruz County intergroup.”

(Amended) “exempting voting members added to the group august 31 2023 (or later) from any restructuring of the group resulting from approval of this motion.”

Deb served as parliamentarian for this discussion and vote.

Attendees contributed first as representatives of group inventories taken at meeting level. There was a common thread observing that it was unclear what kind of “restructuring” a “yes” vote would generate. A member noted that the problem seemed a safety issue, and as such would not be directly impacted by a change of officers. Another said his group felt the matter was an internal committee issue, though members expressed a position that all members in AA should feel safe.

Thomas felt calling a vote on the motion would be the most productive path, given the long time frame the matter has been discussed.

Personal opinions and comments were then entertained.

Shares were limited to two minutes, and relevance to motion at hand.

Opinions offered were varied and addressed different aspects of the motion, as well as suggested considerations in moving forward. There were several suggestions that a mechanism needs to be developed to resolve issues more promptly.

A member reviewed the recent decision to add a code of conduct to the meetings, as well as the completion of a group inventory.

Another restated that she does not feel safe in AA.

Two members said they feel the environment of the meeting is unsafe and toxic.

A motion to call for a vote was presented by Thomas, seconded by Magi.

There were 8 “yes” votes”, 20 “no” votes, and 4 abstentions.

The minority was offered an opportunity share their comments, and several did so.

Voters were polled again, no one opted to withdraw or change their vote.

The motion failed.
