Chair: Magi: Asks for Reps to connect with their groups and see if they have an area rep.

Zoom – any issues with folks logging in via phone. Check the screen – little I in the corner has the number for the access code.

Fire – Lots of things postponed. Was hoping for more info on in-person meetings.

Town Hall postponed. Coming soon

Any Member of Intergroup or AA may submit anything to Magi, and she can place discussion on the agenda. Improvement ideas are welcome. Asks for Questions, Grey question – can we change the voting to people in attendance at a meeting? Changes must be made in the Bylaws

Intergroup is 2/3 of current voting members in attendance.

Emergency Meetings Committee: Rylee: Has been bringing AA meetings to Evacuation Centers. Has 5 meetings going – started with 7. People are returning home and shelters are closing. Monitoring closures, and determining where the need is going to be. Received a lot of donated book-bin is overflowing and 2<sup>nd</sup> bin has been added. Two of the larges centers have 20 people attending. Some people have initiated their own meetings. Fairgrounds seems to be winding down. Civic Center, Harbor High and Twin Lakes have meetings. #### Lauren F. Adhoc committee for re-opening meetings.

17 page document included with agenda includes Covid Information from County Health, CA Public Health and CDC Website. Governor has the last word but often refers to the County. Areas are color coded and our area isn't doing so good, so our rules

will be more strict, but the language is vague and confusing. Bottom line we are still under SIP order. To stay safe, wear a mask in outside meetings. Questions?:

Grey – Are homeless people exempt? It's not identified in any material

Seth – Heard that NA approached county health and got approval for essential service. AA is considered industry guided limited services. AA is not exempt from any public health order. He only heard through the grapevine, and Lauren does not have confirmation.

Yolanda: The material doesn't show deviation from the rules. Cited 4<sup>th</sup> Tradition. Each group is going to decide – but we have to be careful about affecting other groups. . Magi - This is only a sharing of information we will not be directing groups.

Marisol also participates in the Adhoc committee, and noted many questions about opening any meetings. When meetings happen, get the word out. Noted more service positions needed for mask monitoring, etc.

Mary K. How large can an outdoor meeting be? In June, the rule was no more than 10 people. Does this still stand? Lauren didn't find a rule, but the SIP is in affect. She is wondering if she puts this in the newsletter, should the document be part of it? We'll wait to see what the tier system says.
